DES MOINES, IOWA, MAY 16, 17, 18, 1906

By virtue of Article 37, Conference of 1905, the Publication Board, Home and Foreign Mission Boards, as well as the Examining Board convened at Gospel Temple, Des Moines, Iowa, on Tuesday, May 15, at 10 A. M., and were called to order by permanent Conference Secretary with an opening prayer, following which Bishop Jacob N. Engle was chosen chairman and Eli M. Engle, Secretary pro. tem. The Examining Board, which however had not been called, but on account of pressing work were requested to convene in the afternoon following the session, Bishop Jonathan Wert was substituted for Bishop Charles Baker, absentee.

The Publication Board and Home and Foreign Mission Boards then proceeded to make arrangements for their respective sessions, to consider the work to report to Conference, after which the meeting was dismissed with announcements for services in the afternoon and evening for those who were not connected with the respective boards.

Wednesday, May 16, 1906, Conference of the Brethren in Christ, U. S. A., and Canada, convened at Gospel Temple, Des Moines, Iowa, and opened with prayer service at 9.30 A. M., following which the retiring Moderator, Bishop W. O. Baker, introduced

the organization of Conference by appointing the Brethren A. B. Musser, H. L. Trump and M. L. Hoffman a committee to conduct an election for Moderators, which resulted as follows: Moderator, Bishop M. H. Oberholser, First Assistant, Bishop J. N. Engle, Second Assistant, Bishop W. O. Baker. The Moderator elect then read 2 Peter, first chapter, as a basis for a guide for the discipline of Conference and followed with appropriate remarks. The Moderators elect then appointed Bishop J. N. Hoover, Secretary, Girvin Bearss, Assistant Secretary and M. L. Hoffman, Reading Clerk, who were confirmed by Conference.

Note.—On account of the volume of matter before Conference for consideration, it was decided to dispense with the reading of the Minutes of previous Conference, and the following work was considered: Art. 1. The Moderators appointed Bishops Aaron Martin, J. B. Wingert, and the Brethren, Peter Climenhaga, John F. Stump, S. B. Longenecker, B. B. Engle and D. V. Heise, a committee to appoint members to serve on the Examining Board, Publication Board, Home and Foreign Mission Boards for confirmation, to serve for the following Conference year, and to report their appointments to Conference not later than noon of the second day of Conference.

Art. 2. The General Conference Index Committee who had reported under Art. 3, Conference 1905, and who were not discharged, reported the following:

The report stated that there are a large number of books unsold, and that it is found that in some Districts, there are comparatively few books distributed, whereupon an immediate effort was made to give an opportunity for volunteers to distribute the books throughout the respective districts of the Brotherhood, which resulted in a number of books

being subscribed for, to nearly liquidate the deficit, whereupon Conference ordered that a proposition from the individual members of the committee to assume the shortage on condition that the individual members of the committee be allowed to retain the balance of books unsold, until they could realize sufficient to cover the deficit, on condition that the committee be discharged, should be accepted.

Art. 3. The Trustees authorized under Art. 20, Conference 1905, to solicit contributions towards buying the Chicago Mission property, reported as follows:

The balance unpaid is borrowed at 6 per cent., on condition that the money can be paid on the loan as it is received. Conference approved the report, with the following suggestion: That the Trustees should be retained as solicitors also until the total amount can be realized.

Art. 4. Conference confirmed Jacob K. Kreider, substitute for H. K. Kreider, for this Conference on the Publication Board, and Jerome Funk substitute for C. S. Lesher, for this Conference, on the Foreign Mission Board.

Art. 5. The Executive Board presented a report stating that Brother Levi Doner, a returned missionary from South Africa, had been ordered to be ordered as a minister on the recommendation of the Foreign Mission Board, which was confirmed and the credentials ordered placed on record as follows:

TO WHOM THIS MAY CONCERN: This is to certify that. Brother Levi Doner, formerly a member of the Nottawa District, Ontario, and who had been engaged in Foreign Mission work in and about the Matoppo

Mission, near Bulawayo, South Africa, for a period of about four years, and who has returned on furlough during the spring of 1905, to the U.S. A., and who now contemplates to return to South Africa again, to take up Foreign Mission work as it shall be outlined to him by the Foreign Mission Board of the Church of the Brethren in Christ, that by virtue of a recommendation of the workers of the Matoppo Mission, Bulawayo, South Africa, and by virtue of a recommendation and resolution of the said Foreign Mission Board, authorizing the said Brother Levi Doner to be ordained as a minister of the gospel, that he, the said Brother Levi Doner, is hereby acknowledged, and regularly ordained as a minister of the gospel, for and under the auspices of the Church of the Brethren in Christ of the U.S. A., and foreign countries.

Art 6 The General Executive Board also presented a report of their work in Philadelphia Mission District, stating that since the Philadelphia Mission District had not been regularly provided for by a Bishop as overseer, and that for the last Conference year, the Board granted the Mission District the privilege to select a Bishop to serve when needed;

Whereupon a petition from the Penna., State Council, 1906, asking General Conference to appoint an overseer of the Philadelphia Mission District, as well as a petition from the Philadelphia Mission District Council praying Conference to let the decision of the

Executive Board remain, with an amendment that instead of the laity of the Mission District to select a Bishop to serve when needed, that seven brethren, who have previously been chosen, select a Bishop to serve when needed, were considered together, and decided that Bishop Aaron Martin shall have the oversight of the District until Conference shall order otherwise.

Art. 7. Bishop Jacob K. Kreider reported a balance of \$191.97 in the General Church Treasury, which is the balance of the fund obtained from the sale of the Altoona, Iowa church property for use of the Church in Iowa only. The report was confirmed with instructions that the money can be used only according to the original terms of the donor.

Art. 8. Conference ordered that traveling, as well as postage and correspondence expenses of the permanent Conference Secretary, shall be paid out of

the General Church Treasury,

Art. 9. Conference ordered an assessment of five cents per member throughout the various Districts which are included in the original corporation, and that an opportunity shall be given to other Districts who are not included in the original corporation. All such money derived from said assessment to be paid to Bishop Jacob K. Kreider, General Church Treasurer, R. D., No. 10, Lebanon, Pa.

Art. 10. Conference appointed Sister Sarah Bert, of Chicago, Ill., as the Church representative, with orders to recommend and countersign applications for clerical orders and rates at Chicago, on behalf of the

Brotherhood.

Art. 11. Conference ordered that the names and addresses of all the official members of the Brotherhood, including Bishops, Ministers and Deacons, be inserted in the Conference Minutes of 1906.

Art. 12. A petition to define how members who apply their labors to other organizations in Mission

work shall be dealt with, was referred to a commit-

tee of five, who reported as follows:

That all Mission workers, Home and Foreign, who do not work in harmony with the accepted doctrine as taught and believed in by the Church and practice otherwise, shall not be held in full fellowship, and shall be amenable to either the Home or Foreign Mission Board under whose supervision they are, and if not obedient, after being kindly and duly admonished, be dealt with according to the nature of their disobedience.

Art. 13. Conference ordered to issue a suitable tract, setting forth the name and doctrine of the Church in condensed form, and appointed a committee of three brethren, with instructions to proceed at once to formulate a tract as stated, and to proceed with the publication for distribution by the General Church Secretary. Committee, Bishops W. O. Baker, J. R. Zook and Brother D. V. Heise. In connection with the above, Conference ordered to establish a Tract Fund, and appointed A. B. Musser, Harrisburg, Pa., as Treasurer, with instructions to solicit and appoint solicitors throughout the Brotherhood, for contributions to said fund, whereupon an opportunity was given for a free will offering which amounted to \$40.15, with further provisions that, a certain price per hundred shall be named for all tracts so published, which amount shall be paid to the Tract Fund Treasurer.

Art. 14. A petition to strike off Art. 4, Conference 1871, and Art. 13, Conference 1878, from the Church record, if not consistent with the Word of God, was referred to a committee of five which reported as follows:

Resolved, That the vital points embodied in the aforesaid Articles are of too large a scope to be considered within the bounds of this committee, and

Resolved, That since these Articles, as well as

others are more or less ignored throughout the Brotherhood, that this Conference will order that the spirit of submission as embodied in the Apostle Paul's letter to Romans, 14 chapter, 21-22 verse, shall be observed, and

Resolved, That the ministry in the Brotherhood shall do more intelligent teaching on the issue as embodied in these Articles setting forth the inconsistencies which have caused offence, and

Resolved, That since Conference orders submission pertaining to Art. 4, Conference 1871 and Art. 13, Conference 1878, the same submissive spirit shall be manifested to Art. 4, Conference 1872, Art. 5, Conference 1877, Art. 4, Conference 1879, Art. 5, Conference 1887, Art. 8, Conference 1872, Art. 7, Conference 1880, Art. 2, Conference 1883, Art. 12, Conference 1895, Art. 4, Conference 1899, Art. 18, Conference 1901, Art. 42, Conference 1903, and

Resolved, That all said Articles shall remain and be a part of the Church Records until Conference shall order otherwise, and

Resolved, That Section three, page 282, of General Conference Index shall especially be observed in connection with the Articles in this question. Committee: Bishop Jacob K. Kreider, Bishop Jonathan Wert, T. A. Long, A. M. Engle, Kas., and S. R. Smith.

Art. 16. A petition to strike off the General Church record Art. 3, General Conference 1882, if not consistent with the Word of God, was considered and referred to a committee of five, consisting of Bishop Jacob K. Kreider, Bishop Jonathan Wert, Bishop H. L. Heisey, T. A. Long and A. M. Engle, Kas. The report was approved as follows:

We, the committee appointed to consider the advisability of striking from the General Church Record Art. 3 Conference 1882 if not consistent with the Word of God, decided that when a member for any valid reason is disowned by the Church, to fellowship such member, and hold religious services with him is not conforming to the spirit of the letter, Matthew 18, and therefore could not see the propriety of striking from the Church Record said Article, but would admonish the brethren everywhere to use forbearance, and show love, but be firm in the teaching of the Gospel, and therefore refer to 1 John 2:19, "They went out from us, but they were not of us, for if they had been of us, they would no doubt have continued with us, but they went out that they might

be made manifest that they were not of us." Romans 16 chapter 17 verse, "Now, I beseech you brethren, mark them which cause divisions and offences contrary to the doctrine which ye have learned, and avoid them."

Art. 17. Conference authorized the incorporation according to law of the Brethren in Christ Fire Relief, in the State of Pennsylvania, for the use of the Brotherhood at large.

Art. 18. Conference considered the advisability of deeding the Church and Mission property in the city of DesMoines, Ia., which at present is held in trust for the use of the Church at large, to trustees to be named by the DesMoines District, and the property to be for the sole use and disposition of the Church in DesMoines District. Decided that the title to the property should remain indefinitely as it is.

Art. 19. Conference decided that General Conference of 1907 shall convene at the Messiah Home, in Harrisburg, Pa., on third Wednesday of May, 1907.

Art. 20. Conference authorized the Home Mission Board, to revise the present form of questions for examining applicants for Home Mission work, so that they will meet their peculiar needs, on condition that said revision shall be examined and approved by the Examining Board before authenticated.

Art 21. Conference considered, approved, and authorized a resolution as follows:

Resolved, That General Conference of 1906, appoint a committee of five brethren, representatives of various gifts, who are authorized to proceed at once with the compilation and publication of a Church Hymnal, consisting of from three to four hundred selections, with and without written music, and in such binding as may be considered most suitable. The selections to be expressive of themes suitable for public

worship, as well as Sabbath School and evangelistic services, and

Resolved, That General Conference of 1906 appoint a brother not a member of the committee, who shall solicit and receive contributions and offerings toward a fund to be called the Church Hymnal Fund, who shall only pay money on vouchers which are properly issued by the Church Hymnal Committee after they have properly organized. Conference appointed George Detwiler, Harrisburg, Pa.; D. V. Heise, Clarence Center, N. Y.; Bishop A. M. Engle, Dayton, Ohio; Bishop J. R. Zook, DesMoines, Iowa; and S. R. Smith, Harrisburg, Pa., a Church Hymnal Committee to proceed as outlined in above resolution.

Art. 22. Conference appointed A. B. Musser, 68 N. Twelfth St., Harrisburg, Pa., Treasurer of the Church Hymnal Fund, to whom all contributions and offerings as outlined under Art. 21, shall be forwarded.

Art. 23. Conference considered a petition of Ohio State Council to admit the Brotherhood in the State of Ohio as a part of the original corporation as incorporated in the State of Pennsylvania, May 4, 1904, according to the following petition, and ordered the same accepted and placed upon the record of the General Church Secretary.

TO GENERAL CONFERENCE OF THE BRETH-REN IN CHRIST, ASSEMBLED IN DES-MOINES, IOWA, MAY, 1906. GREETING:

We, the Brethren in Christ of Ohio, assembled in State Council at Fairview, Montgomery County, Ohio, March 16 and 17, 1906, pray General Conference of 1906 to admit the Bretherhood in the State of Ohio as a part of the original corporation as incorporated in the State of Pennsylvania, U. S. A., on May-4, 1904, and confirmed by General Conference of 1904 under Art. 8, according to the method as outlined in

the Constitution and By-Laws of the corporation under Art. 17, and further we pray General Conference of 1906 to take recognition of the names and locations of the following houses of worship, together with the names and addresses of the trustees representing the following places of worship, and place them on the General Church record of the original corporation as incorporated in the State of Pennsylvania, on May 4, 1905.

Art. 24. Conference ordered that hereafter at the beginning of each Conference after organization, the Moderators elect shall appoint a committee of twelve representative brethren whose duty it shall be to appoint three Bishops to constitute the Examining Board, seven brethren to constitute the Publication Board, twelve brethren to constitute the Home Mission Board, and seven brethren to constitute the Foreign Mission Board, and report their appointments to Conference not Jater than the second day of Conference, for confirmation, to serve for the following Conference year. All these boards shall organize and report their organization to Conference to be spread on the Minutes.

Art. 25. Conference ordered that in future Conferences all the permanent boards shall meet at 10 A. M., Tuesday preceding the opening of General Conference, for considering and tabulating their work to be presented to Conference.

Art. 26. Conference considered a question, asking for an outline of the duty of a pastor, and ordered the following to be recorded.

A pastor, technically speaking, is a feeder of a flock, in a more extended sense, a preacher of the Gospel to saint and sinner; a watchman on the walls of Zion; an administrator of the rites of the church; a pastoral visitor, and a spiritual advisor.

Art. 27. Conference recognized the Brotherhood at Carland as a Mission District, and ordered it to be under the general supervision of the Home Mission Board.

Art. 28. A petition from Carland Mission District, asking how provision can be made for ministers who have charge of ministerial work, who are limited in their circumstances, was referred to the Home Mission Board to be dealt with as the case may warrant.

Art. 29. Conference ordered the following to be inscribed on the church record:

Resolved, That this Conference discourage the marriage of brethren and sisters with persons who are unconverted, since it is inconsistent with the Word of God as set forth in the following scriptural references; and

Resolved, That special attention shall be given to teach more on these lines. References: Genesis 6: 1-3; Amos. 3:3; 1 Cor. 7:39; 2 Cor. 6: 14-18.

Art. 30. A report was given from Upland, Cal. District, by letter, as well as a verbal report by Brother J. B. Leaman. which purported that the Lord's work in that District is progressing to the honor and glory of God. The report was accepted and ordered inscribed on the Minutes.

Art. 31. Conference confirmed the appointment of the following trustees for Cross Road Meeting House. Lancaster County, Pa.: Henry B. Musser, elected instead of Martin Wolgemuth. deceased. Belle Springs Meeting House, South Dickinson County, Kas.; Levi Hoffman, instead of Henry Bowers.

Art. 32. Conference considered the advisability of establishing a Training Home and Bible School, and after considerable discussion for and against, Conference ordered that the following resolution be inscribed on the Church Record:

Resolved, That we (The Church) have a Missionary Training Home and Bible School.

Art. 33. Conference authorized that it shall be noted on the Minutes of this Conference, that all contributions to DesMoines Mission for Mission purposes, are applied to the sustaining of the Mission, and not to the regular Church expense in DesMoines District.

Art. 34. Conference considered a petition to investigate whether the Mission property located at 737 Ninth Street, DesMoines, Iowa, is adequate for public worship and submitted the same to a committee of five brethren, consisting of Bishop Henry B. Hoffer, Eli Hoffman, A. B. Musser, Jerome Funk and E. S. Engle, who investigated the condition of the Mission property and reported the following, which was adopted:

Resolved, That the present building located at 737 Ninth Street, DesMoines, Iowa, used for mission purposes, is inadequate for public worship, and

Resolved, That the present Mission building should be moved to the rear part of the lot and an effort made to remodel it without too much expense, so that it would be in a condition to bring in a rental, and

Resolved, That a new Mission building shall be erected on the front part of the lot, the cost of the building not to exceed \$3,500.00, and

Resolved, That the trustees in charge of said property shall not proceed to erect said building until two-thirds of the entire cost of the building be available, and

Resolved, That if the trustees together with the consent of the donor's deem it better to sell the said Mission property and locate in some more favorable place, that they be hereby authorized to do so.

Art. 35. Brother J. B. Knupp, of Garrison, Iowa, tendered his resignation as trustee of DesMoines

Mission property, which was accepted, and Brother Jacob H. George, of DesMoines, Iowa, was appointed to fill the vacancy.

6th. That the Associate Editors are: Bishop W. O. Baker, Louisville, Ohio; Bishop M. H. Oberholser, Culbertson, Pa., and S. R. Smith, Harrisburg, Pa.

Art. 37. A question was presented to Conference asking whether it would not be advisable to exercise more care in admitting articles for publication in the Evangelical Visitor, the teaching of which is not in harmony with the accepted standard and doctrine as believed in and taught by the Church; whereupon Conference ordered that, the Editors shall exercise special care in admitting articles for publication which may conflict as above stated.

The committee in charge held an election and reported the selection of Bishop J. N. Engle, of Hope, Kas., to have the oversight of Dallas Center, Benton

and Black Hawk Counties District.

Art. 41. Conference appointed J. M. Hostetter, Mt. Joy, Pa., to make arrangements with railroad companies for rates for Conference of 1907.

Art. 42. Conference appointed Brother George Detwiler, Harrisburg, Pa., Assistant Conference Secretary, for next Conference year.

From the above report it will be seen that there has been an extra expense added to the Orphanage since last Conference, by virtue of the school which as organized Sept. 11, 1905, which amounted to \$300.00. It will also be noticed that there improvements amounting to \$80.00.

The school item, together with the cost of fuel and wages for janitor, will make it considerably over \$400.00. Besides this, there is a car load of coal on hand, amounting to about \$75.00, as well as a school supply.

It will be seen from the above report that, the debt was increased from \$586.91 last year, to \$65.30, which was due to the school item, which however proves to be one of the best ventures the orphanage management has made since in existence. There is a model school conducted in the Orphanage averaging about 23, taught by Sister Mary Hoffman, of Mount Joy, Pa. It is a great satisfaction to see that the children in their school life are sarrounded by Bible influences, which, will more or

less tell in their lives, since it was heretofore a painful truth that the good morals which were taught in the Orphanage, were more or less obliterated by the evil influences with which the pupils came in contact with in the common schools.

There are at present 28 inmates in the Orphanage, ranging from about one to 17 years of age, eight of whom have united with the church, and have a bright prospect of becoming efficient workers in the cause of saving souls.

Sec. 11. Whereas, Henry and Anna Angeny, who were ordained and sent forth by the Church to labor as its representatives in the India field, but who for reasons best known to themselves, have taken an attitude hostile to the Church, withdrawing their membership and uniting with a different body.

Resolved, That this Conference accepts their resignation, recognizing however, that the case merits

severer judgment.

Sec. 12. Resolved, That the Foreign Mission Board be authorized by this Conference to write Brother Amos L. Musser and co-workers in India, a private letter giving them instructions as to their

locations and restrictions in relation to their business engagements.

Sec. 13. Since Henry Angeny and wife have tendered their resignation which was accepted as stated under Section 11, and since the Church had placed considerable confidence in their effort, and by their withdrawal the work in India has seemingly suffered

Resolved, That the Foreign Mission Board shall call for a proficient leader to take charge of the work in India.

GENERAL FOREIGN MISSION SUGGESTIONS.

Sec. 14. Whereas, The list of questions for examination of applicants for Foreign Mission work has proven inadequate,

Resolved, That the Foreign Mission Board be authorized to revise said formula of questions for the use of the applicants for Foreign Mission work. Such revision to become authenticated only upon the approval of the Examining Board.

Sec. 15. Whereas, The Foreign Mission Board has suffered embarrassment through letters of recommendation from the Home Districts of applicants for Foreign Mission work, and whose qualifications might be questioned by the Foreign Mission Board. and yet through some recommendations be seemingly obliged to accept such applicants.

Resolved, That all Districts giving letters of recommendation to applicants for Foreign Mission work. should exercise the utmost care to avoid such embarrassment and not favor the person at the expense of the cause.

Sec. 16. Resolved, That the foregoing preambles and resolutions be reproduced on the Minutes of this Conference.

Sec. 17. Sketch of report of Eli M. Engle, Secretary of Foreign Mission Board, U. S. A. and Canada, to General Conference, 1906.

Brother Harvey Frey and wife, Emma Frey, and Sisters Adda G. Engle and Abbie M. Bert, who were ordained May 19, 1905, as Foreign Mission workers, in company with Sister H. Frances Davidson, who had previously returned from Matoppo Mission, South Africa, sailed for Matoppo Mission, South Africa, on American line S. S. St. Louis, from Pier, No. 15, New York City, on June 17, 1905, at 9.30 A. M., arriving at Matoppo Mission in Rhodesia, South Africa, on August 2, 1905; reporting a prosperous voyage, witnessed with God's blessings all the way to such an extent that transportation for their baggage, which amounted to over 3,000 pounds, was granted gratis from Harrisburg to Southampton, England.

Conditions of a grave nature arose among the workers in India, to such an extent that Henry Angeny and wife, Anna Angeny, withdrew themselves from the workers and the Church, of which Conference has been informed. Brother A. L. Musser, in a letter to the Chairman of the Foreign Mission Board, dated May 4, 1905, made the following inquiry:

1. "Shall, or must we teach these people to wear the same covering as our sisters wear? expressing himself thus: "These women have a better covering than our sisters, and it is more according to the Gospel than the one the brethren have selected."

2. Also concerning open communion privileges, to which the Board in a letter dated July 3, 1905, made

the following reply:

"In reference to the prayer veiling will say that, the Scripture is silent as to the form of it, but evidently must be modest and especially for said purpose. It is hardly in the power of the Foreign

Mission Board to suggest or grant any changes from the present form so general in use, but it would rather belong to General Conference for decision. However, in the judgment of the Board, there seems to be no impropriety in adopting some uniform form in India, if fully as modest and becoming as our present accepted form, providing there are good reasons for such changes. However, it should be wisely, carefully and prayerfully considered, to avoid rash and hurtful conclusions, which would prove detrimental in the future.

"In answer to the question on the Eucharist, will say that, the Church has never been strictly close nor open communists; if Christians of other denominations have a special desire to commune with you, 'who are living epistles known and read of all men,' and adhere to the regular established order of the Church, such as prayer veiling, washing of Saints' feet, etc.; we see no reason why this is not permissible. (See Minutes General Conference, 1876, Art 1.)

"We hope that you may use wisdom and discretion on all lines, and rather be a little reserved than too lax. We desire you to be perfectly frank on any topic you may deem necessary, so there may be a

perfect co-operation and unity."

The above reply was signed by every member of the Board. In respect to petitions, suggestions and questions from Matoppo Mission, adopted the following resolutions by circular letter dated October 8, 1905:

1. Whereas, Brother and Sister H. P. Steigerwald have earnestly requested the Foreign Mission Board to allow them a change of climate on account of their impaired health, and since the success of our Foreign Mission work depends so much upon the good health of our missionaries, and since death is so often caused in those climates by overwork,

Resolved, That Brother and Sister Steigerwald be

granted a leave of absence for four months from their post of duty, and also remit them One Hundred Dollars for traveling and living expenses, and

Resolved, That it the said One Hundred Dollars be insufficient, that the Secretary of the Foreign Mission Board shall issue a voucher properly signed for the deficit.

2. Whereas, there is a question as to the propriety of seating or placing seats of some kind in the Church building at Matoppo Mission, for which no provisions have as yet been made, and

Since the building is incomplete and unfit for ser-

vices without seats of some kind,

Resolved, That Elder H. P. Steigerwald, be instructed to place seats of some kind in their house of worship, as he and the workers may decide upon using all possible economy, and that if our present fund does not warrant such expense that a special collection for such purpose be taken throughout the various Districts of the Brotherhood.

In concurrence with H. P. Steigerwald, and Sister H. Frances Davidson, the Foreign Mission Treasurer placed an order for two wagons for African Mission use, the one for the Matoppo Mission, the other for the use of Sister Davidson for the establishment of a station farther in the interior of Africa. The wagon for the Matoppo Mission to be paid out of the General Fund, and the one for Sister Davidson to be paid out of the free will offerings made to her during ner visit to America. The wagons were shipped to Africa early in the spring of 1906.

Sisters Elizabeth Engle and Maria Werkman, both of Kansas, made application for Foreign Mission workers, and upon recommendations by their Home Districts, they were referred to the Examining Board, who recommended them as to their qualifications, whereupon the Board granted them certificates of acceptance and approval for Mission work

in South Africa, subject to instructions of said. Board.

Brother Levi Doner, who was ordained as a minister for South Africa, as will be noted under the report of the General Executive Board, under Art. 5, of this Conference, who had returned to America on furlough, sailed again for South Africa, on March 3, 1905, on S. S. City of New York, from New York City to the Matoppo Mission Station, at Rhodesia, South Africa.

The above abstract report was ordered to be spread on the Church Records.
