INTRODUCTION.

The different sessions of General Conference of 1008 were all preceded by a season of song service and worship, beginning on Tuesday, May 19, at 9.30 a. m. as well as afternoon and evening. together with morning, noon and evening worship preceding the different sessions during Conference. Every evening beginning with Tuesday following the Conference sessions, regular preaching services were held, conducted by visiting brethren from different parts of the Brotherhood. On Thursday and Friday three sessions were held beginning respectively at half past eight a. m., one and six p. m., except Friday evening, preaching services were conducted in open air while Conference was in session until nearly midnight with a concluding session beginning on Saturday morning, May 23, at 6.30, and continued to 10 a. m. when Conference adjourned.

On Tuesday, May 19, 1908, at 9.00 a. m., the Examining Board, Publication Board, Home Mission Board and Foreign Mission Board of the Brethren in Christ, met at Heise Hill Church near Gormley, Ont., and opened with song service and prayer, conducted by H. R. Heise, Elder of the District, who then appointed Bro. Jonathan Lyons, Secretary pro tem. The roll of the respective Boards was called, and the substitutes appointed by absent members were admitted. The members of the different Boards were instructed to immediately take up the work of formulating their reports for Conference.

WEDNESDAY, MAY 20, 1908.

After a short service, Conference of the Brethren in Christ of the United States of America and Canada convened at Heise Hill Church near Gormley, Ontario, and opened with thirty-minutes devotional services at 8.30 a. m. At 9.00 a. m. the permanent Conference Secretary formally opened Conference with the assistance of the re-

tiring Moderator leading in song service and prayer. The retiring Moderator appointed the Brethren, D. V. Heise, A. B. Musser and John-R. Herr, a committee to hold an election by ballot for Moderator, which resulted as follows:

The Moderators-elect then appointed Brother M. L. Hoffman, Reading Clerk, and Brethren Geo. Detwiler, Secretary; D. W. Heise, Assistant Secretary, and H. L. Smith, who was chosen assistant to the Secretary during his absence in connection with the Home Mission Board. The Moderator-elect then read I. Cor. 13:1-13, and earnestly admonished the members of Conference to manifest the Spirit of Love in their considerations during sessions of Conference.

Unfinished Business.

Art. I. Section I. The Church Hymnal Committee presented its report, which was approved.

Sec. 2. Conference decided that the Church Hymnal decision under Article I of Unfinished Business of 1907, be reconsidered. Sec. 3. Conference decided that round notes be used in the proposed New Church Hymnal. Art. 2. The Church Hymnal Fund Treasurer, Bro. A. B. Musser, presented his report as follows, which was approved: On hand May 1, 1908, \$1,965 60 GENERAL EXECUTIVE BOARD. Art. 3. Sec. 1. The report of the General Executive Treasurer, A. B. Sec. 2. Conference decided that the various Districts in the Brotherhood be and are hereby instructed to make an assessment of 5c. per member, to be applied to the General Executive Fund. Fund.

Sec. 3. The report of the General Executive

Secretary, S. R. Smith, was presented in part as

follows, and approved:

The General Executive Board was called on three occasions during the last Conference year. First call, December 27, 1907, to Souderton District, Pa. Second call to Wainfleet District, Ont., on February 3, 1908. Third call to Mowersville

District, Pa., on April 11, 1908.

In all of the three executive meetings, there was a sentiment of love expressed even though differences of opinion existed. The evidences so far as the Board has learned seemed to prove that the work that was undertaken in weakness may prove beneficial to one or the other. May the Lord direct that the spirit of love, peace and

unity may prevail.

Since the General Executive Board is so widely scattered, it has been a serious question whether some other plan could not be devised that would eliminate the traveling expenses incurred by the Board meeting at distant places when there are individual differences which finally become a district matter, where seemingly some one or more has at some time erred which led to widen the breach and thus both sides more or less transgressed.

The questions of how to meet the traveling expenses of the Board is a serious one, the Board therefore suggests that Conference should place itself on record as to how the Board is to deal in reference to traveling expense, etc., with

such Board meeting.

Sec. 4. Conference decided that the General Executive Board shall be empowered, in case of necessity, to draw on the General Executive Fund, to meet expenses accruing from its being called to investigate Church matters.

Art. 4. Sec. I. A. B. Musser. Treasurer of the Tract Fund, presented his report as follows,

which was approved:

Sec. 2. Conference decided that the committee appointed under Art. 13, Conference of 1906, known as the Tract Committee, consisting of W. O. Baker, J. R. Zook and D. V. Heise, shall be known as a permanent Tract Committee, and shall be authorized to publish a variety of tracts, with the provision that the treasurer then appointed, and the conditions then authorized, shall be retained.

Sec. 3. Conference decided that all tracts intended for publication in the Evangelical Visitor shall be approved by the Tract Committee before

publication.

Art. 5. Sec. I. The report of S. R. Smith, Treasurer of the Editor's Extra Fund, as authorized under Art. 27, Sec. 3, page 18, Conference 1907, was presented as follows and approved:

Sec. 2. Conference decided that the balance on hand of the Editor's Extra Fund, amounting to \$55.44, shall be paid to Geo. Detwiler, Editor of

the Evangelical Visitor.

Art. 6. Sec. 1. The General Secretary, as authorized under Art. 16, General Conference 1907, reported that he has not published any letterheads, etc., as authorized, on account of no provision having been made to defray the expenses, with the further statement that numerous requests have been made for letter-heads and envelopes, as authorized in the aforesaid Art. of different sizes and styles, which would involve considerable outlay. The above report was ap-

proved with the following:

Sec. 2. Conference decided that the Tract Committee, as authorized by this Conference, under Art. 4, Sec. 2, shall proceed with the publication of letter-heads, etc., as outlined in Art. 15, General Conference 1907, and that the expenses for the same shall be taken out of the Tract Fund.

Sec. 3. Conference decided that the Letterhead Fund and the Tract Fund be consolidated and that the work thereof be placed in the

hands of the Tract Committee.

Art. 7. Sec. 1. Art. 20 of Conference of 1907, which called for an amendment of the Constitution and By-Laws, authorizing the election of Moderator by informal ballot instead of by single ballot, was decided to be postponed for another year, and be referred back to the several districts in order to obtain a full expression of all the Districts by popular vote, and that each District report to S. R. Smith, Permanent Conference Secretary, before May 1, 1909, and the said decision to go into effect before the organization of Conference.

Art. 8. Report of the Treasurer of the Incorporating Board of the Bible School and Missionary Training Home, as authorized under Art. 25 and 26 Minutes Gen. Conference 1907, as

follows, which was approved: Sec. 1. Treasurer's financial report was as

Sec. 2. Since Conference of 1907 made no provision to cover the expenses of the above named Incorporation Board, it was necessary in order to undertake the work that means were provided, the Board therefore decided to borrow this amount on their own responsibility from the Home Missionary Board, with the condition that if General Conference decided not to approve and make provision for it; that the Board will individually provide.

Sec. 3. Conference decided to provide for the above need by authorizing, that it be taken from

the General Fund.

Sec. 4. The Secretary of the Bible School and Missionary Training Home Incorporating Board presented a report of which the following ex-

tract was approved.

On May 18, 1907, a preliminary organization was effected, and on June 18, 1907, the Board met at the Buffalo Mission, Buffalo, N. Y., and had a three-days' session of three sessions each day, during which time a school curriculum was adopted, together with qualifications for teachers and students as well as for the Board of Managers. The organization as then effected was D. V. Heise, Chairman; Chas. Baker, Assistant Chairman; S. R. Smith, Secretary and Treasurer; E. M. Engle, Assistant Secretary. The proceedings of the Board were printed in pamphlet form.

Sec. 5. The Incorporating Board as elected under Art. 26, General Conference 1907, tendered its resignation, which was approved. The Board as resigned were: D. V. Heise, Chas. Baker, J. N. Engle, B. F. Hoover, Eli M. Engle, S. R. Smith, A. M. Engle, not present.

Sec. 6. Conference decided to consider the report of the Minutes of the Bible School and Missionary Training Home Incorporating Board as published in pamphlet form in open Conference, which was done by considering it in articles and sections and approved the report as a whole with the following changes:

Art. 2. Page 5, third line from top of page, strike out the words, "of the United States."

Art. 2, Page 5, insert "Elementary Physiology."

Art. 5. Page 6, substitute the word, "General" for the words, "United States."

Art. 13. Sec. 1. Page 9, substitute the words, "And whose qualifications shall be equal to a normal education," for the words, "and holding not less than a normal certificate."

Art. 13. Sec. 2, page 9, strike out the words, "And certificate."

"Art. 18. Sec. I, page 20, insert the words, "That which shall hereafter be," so that the fifth and sixth lines of said section shall read, "Home and Foreign Mission Boards, and that which shall hereafter be approved by General Conference, etc."

Sec. 7. Conference approved the Incorporating Board's decision, according to Art. 22, of the Bible School and Missionary Training Home Minutes, in locating the Institution at or in the vicinity of Harrisburg, Pa.

Sec. 8. Conference sustained a motion to increase the Bible School and Missionary Training Home Incorporating Board from seven mem-

bers, as authorized under Art. 25, Sec. 1, page 13, Conference Minutes 1907, to nine members and decided that the Bishops present shall be an elective Board to elect a new Bible School and Missionary Training Home Incorporating Board of nine members instead of seven.

Sec. 9. Report of Elective Board as follows, which was approved. (a) Before proceeding with the election, the question was considered whether or not the members of the original Board were eligible to re-election inasmuch as they had stated before Conference in their reasons for resignation that certain conditions existed which disqualified them for further service. The said conditions were investigated and while it was found that some mistakes had been made, they were satisfactorily adjusted, after which the following brethren were elected to compose the above named Bible School and Missionary Training Home Incorporating Board: J. N. Engle, D. V. Heise, Chas. Baker, S. R. Smith, Eli M. Engle, B. F. Hoover, A. M. Engle, J. R. Zook and C. C. Burkholder.

(b) Since Brother S. R. Smith is so heavily encumbered with other church duties, we, the Elective Board, recommend that Conference authorize the Incorporating Board to appoint a substitute for S. R. Smith, for reason, when he is unable to serve as an active member of the Board

(c) The Elective Board further recommends that the following be spread upon the Minutes of this Conference and also published in the columns of the Evangelical Visitor.

"The misunderstandings caused by an article published in the *Visitor* of August 15, 1907, relative to the Bible School and Missionary Training Home has been amicably adjusted and relegated to oblivion and the Church is unanimous in the project of the Bible School and Mission-

ary Training Home and that it shall be a united effort.

Art. 9. A petition from Philadelphia Mission District to appoint and confirm Bro. Charles Stover, Trustee of Philadelphia Mission property, instead of Bishop Joseph B. Detwiler, was not confirmed, but ordered that the Trustees shall remain as they have been, viz.: Peter Stover, Jos. B. Detwiler and S. G. Engle.

Art. 10. Conference confirmed Cyrus T. Heisev as Trustee for Mechanicsburg church property instead of Henry S. Heisey, deceased.

Art. 11. Sec. 1. WHEREAS, General Conference of 1897 under Art. 3, authorized and ordered a church building to be erected at Glendale, Arizona, and

WHEREAS, the Church property has not been in use for religious services by the Brethren in

Christ for a period of years; therefore, Sec. 2. Resolved. That the Trustees, or the person in whose name the title of the said

property is vested shall be and are hereby authorized to sell the said property at private or public sale, and

Sec. 3. Resolved, That the proceeds of such sale shall be used for religious purposes, as may be authorized by the church in Upland District, California.

Art. 12. WHEREAS, General Conference 1907, Art. 11, ordered that all districts throughout the Brotherhood shall forward a report to the General Secretary, of all officials as well as lay members, etc.; and,

WHEREAS, not all have so reported; therefore, Resolved. That this Conference requests all such Districts who failed to report to do so at

once.

Art. 13. South Dayton District, Ohio, presented a letter to General Conference stating that they wished to be represented by letter to General Conference, expressing that as a Church they are earnestly 'contending for the Faith once delivered to the Saints," and wish the blessing of God on the work of Conference, which was approved.

Art. 14. Conference confirmed Levi S. Herr as Trustee of the Fairview church property, in place of Brother Adam Hocker, deceased.

Art. 15. Conference confirmed David E. Cassell as Trustee for Highland Church property

in place of Jeremiah Hoke, deceased.

Art. 16. Conference decided not to reconsider Art. 52, Conference of 1906, relating to the duties of Home Mission workers, but reaffirms said article.

Art. 17. Conference decided that a distinction be made in giving the names and addresses of Missionaries, in the Evangelical Visitor, so as to distinguish between those who labor in connection with the Foreign Mission Board, and those who are under other Boards or independent.

Art. 18. WHEREAS, Sister Mary Zercher, deceased, of Jefferson, Ohio, has by her will, donated two properties, one located in Jefferson, Wayne county, Ohio, and the other in the town of Smithville, Ohio, to be sold after the death of her daughters intermarried to-Mason and Swinehart—the proceeds of such sales to revert to the Foreign Mission Board of the Brethren in Christ: and.

WHEREAS, The aforesaid heirs of said Mary Zercher desire to purchase the interest of the Foreign Missionary Board of the Church of the Brethren in Christ in said properties for the sum of two hundred dollars for each property, making a total of four hundred dollars, by themselves defraying all the expenses incurred in having proper arrangements made for such purchase; therefore,

Sec. 1. Resolved, That this Conference authorize the sale of aforesaid interests at the prices

named; and,

Sec. 2. Resolved, That the Brethren C. S. Brenner, of Smithville, Ohio, and S. B. Longenecker, of Weilersville, Ohio, to arrange for the carrying out of the above resolution, and when proper arrangements are made, shall be and are hereby authorized to grant to release as the courts may order.

Art. 19. Conference decided to refer the petition from Ohio State Council, referring to deaconesses, to Art. 53, Conference 1902.

Art. 20. Conference decided to refer the petition of the Elkhart and De Kalb County District Council, in reference to the Mennonite Publishing Co's proposition for Sunday-school literature, to a committee of three brethren for investigation and report to Conference of 1909. The committee as appointed are: Enos H. Hess, John A. Stump and D. W. Heise.

Art. 21. Conference decided not to change the time of holding General Conferences.

Art. 22. Conference decided to refer the petition of Shannon District Council, III., referring to the disposal of church property, to the District from which it came, to deal with it in accordance with the Constitution and By-Laws, page 266, Art. 15, Sec. 1.

Art. 23. Conference decided that the Conference Minutes be read separately after each

day's proceedings.

Art. 24. Sec. I. Conference decided that a Ministerial meeting be held in connection with General Conference each year on Tuesday evening of Conference week.

Sec. 2. Conference decided that three well-qualified Brethren be appointed yearly by the

Committee of Appointments at each preceding Conference, whose duty it shall be to formulate a program in selecting such topics as thought most advisable and instructive, and assign said topics, no later than January I, to competent brethren for teaching and discussion at the next Ministerial meeting. Committee: Bishop J. N. Engle, Geo. Detwiler, D. V. Heise.

Sec. 3. Conference decided not to accept the petition of Des Moines District Council to have the same committee assign topics and select ministers, for the preaching services during Con-

ference.

Art. 25. Conference decided not to change the method of amending the Constitution and By-Laws, according to page 271, Sec. 2, of General Conference Index, as requested by Des Moines District Council.

Art. 26. Conference decided that General Conference of the Brethren in Christ of 1909,

convene in Dickinson county, Kans.

Art. 27. Conference decided to appoint a committee of three brethren to investigate and devise plans by which the requirements of the Chicago Mission building may be met. Committee appointed: E. S. Engle, Abilene, Kans.; Wm. H. Kreider, Shannon, Ill., and Henry L. Trump, Polo, Ill.

The committee was empowered to take the necessary steps to secure what funds are needed to carry out the improvements, in whatever way that may be, and having the funds in hand are empowered to proceed with the work according to their best judgment, and report to General

Conference of 1909.

Art. 28. Conference decided to refer the petition of Kansas State Council, asking to provide fire protection for city Mission properties, be referred to the Fire Aid Board officials of the B, in C.

Art. 29. Conference decided, in reference to the request of the Oklahoma State Council, referring to Art. 4 of Kansas Joint Council of 1907, which intimated to have opened the door to life insurance, that former Conference decisions, referring to members having their lives insured shall stand, and that said decisions be interpreted to mean and include all life insurance.

Art. 30. Conference decided in reference to the question submitted by Markham District Council as to whether the present system of a self-supporting ministry is according to the New Testament teaching, that it be referred to a committee of five, who shall investigate the question pending and report to General Conference of 1909 for approval, amendment or rejection. The committee as appointed and confirmed are: Fred. Elliott, W. O. Baker, Henry K. Kreider, Jacob N. Martin and C. C. Burkholder.

Art. 31. Conference decided that the suspending of inconsistent members for a period before final expulsion as referred to in the question from Markham District, Ontario, is Scriptural (II. Corinthians 3:14-15) and is permissible, but Districts are at liberty to act as such cases may require.

Art. 32. Sec. 1. Report of Publication Board.

The number of names on the list is 1890. There are 20 that go to exchange offices, 65 to charity, 20 to institutions and individuals, 25 to foreign mission stations and individuals.

We have been printing 1,950 copies each issue, but will likely need fifty less, as the new ruling of the Post-Office Department will cut off quite a number which fail of being renewed reaching perhaps 90. So that 1850 or 1900 copies will suffice for the present.

The increased item of expense in mailing is due to the new ruling as regards postage on second class matter to Canada.

Sec. 2. The Board accepted a recommendation by the Editor that 1,850 or 1,900 copies be printed.

Sec. 3. The Board requests that solicitors for subscriptions, renewals, collections and local church news should be more active in their work. See list of names and addresses under Art. 27, page 16, General Conference 1907.

Sec. 4. The Board recommends the continuation of the Sunday-school lesson page in the Evangelical Visitor for the following Conference year.

Sec. 5. The Board approved the work of Brother George Detwiler as Editor during the past Conference year, and appointed him as Editor for the following Conference year.

Sec. 6. Inasmuch as the Editor has done extra work and saved about one hundred dollars on the publishing of the Evangelical Visitor.

Resolved, That his salary be raised from \$550 to \$650 for next Conference year.

Sec. 7. WHEREAS, In order to guard the Evangelical Visitor against harmful contribu-

tions appearing in its columns,

To Brethren in Christ Conference, convened at Markham, Ont., Greeting: By virtue of the work assigned in Art. 27, Sec. 6, Conference of 1907, to us as a Committee, we beg to sub-

mit the following report:

We find that the cost of printing per page has in the last few years been materially lessened through the aid of complicated and expensive machinery. The old method of hand type setting has been superceded with the linotype machine and the old hand press with the rapid power press. Much more work can be done in a given time, but it is very difficult to secure a man that can run both the linotype and press machines. It would require about two days to set up the Visitor. The cost of a linotype machine with fixtures is \$4,000, and a first class press 30½x46 in., \$3,000. Second-hand press machines can be had from \$1,200 up.

With no outside printing, the men and machines would not be needed more than a few

days; thus making the outlay too large for the work to be done. Unless the church would wish to enter into general printing for the public, which we deem inadvisable at the present time.

Having found it inadvisable to establish our own printing house at present, we proceeded to get bids for the publication of the *Visitor* as heretofore. The bids received were as follows: The New Era Printing Co., Lancaster, Pa., \$1,457.00 for 24 issues of 1,900 copies each, and \$1.67 per 100 copies additional. They to furnish paper, composition, press work and binding, setting mailing list and keeping it in good condition (making the necessary corrections during the year), furnishing the paper for the same and wrapper, packing and delivering at the Lancaster Post-Office.

Central Printing and Publishing Co., of Harrisburg, Pa., \$950.00 for 24 issues, 1,900 copies, with same service as mentioned under the New

Era bids.

Hill News, of Harrisburg, Pa., \$950.00 for 24 issues, 1,900 copies with conditions as heretofore named, except that the Editor do the mailing.

The printing was done by the Central Printing and Publishing Co., of Harrisburg, Pa., for Conference year ending 1908, as heretofore.

The Committee recommends that in the future, matters concerning the publication of the *Visitor* be left to the Publication Board.

The above figures represent the total cash receipts and total cash expenses, not including donations, such as, clothing and provisions. Following is the report for improvements for past year as authorized by General Conference of 1906. The total expenditure is \$1,032.25, which has all been paid by free-will offering made during the time of building, leaving the building free of all indebtedness up to the present report. The general work at the Mission for the last year has been on the increase. The attendance for the year has been the best since the Mission began. With the present enlargement we are no nearer supplying the needed room than we were before we made the improvements. The Sunday services having been well attended, but the greatest need at the present time is room to properly take care of the Sunday-school. Our attendance during the present year has been as high as one hundred sixtysix. We look forward to the time when the needed room will be amply supplied. Those who have been received into membership by baptism during the last year, are eight in number. This number does not include a great many more who have confessed conversion that have gone elsewhere. The past Winter has been one of great need for the poor. The hard times have been severely felt by our people. Never since the Mission started has there

been such a heavy demand made upon the Mission for provisions and help in general. This has been partly offset by the year just past as being one of the best in donations of provisions and clothing but we can safely say in view of the many donations that have been sent to the Mission by the Brotherhood, the demand has only been half met and we, the undersigned do pray that the Brotherhood might see fit to greatly enlarge the donations in the coming year with much clothing and provisions of all kinds.

GENERAL REPORT.

Sec. 2. It will be noticed by the above report that the actual indebtedness during the last Conference year has been reduced to the amount of \$346.87. We are obliged to say from a temporal view that the Orphanage is increasing in capacity as well as in material. There are at present 35 inmates. No one who has paid a visit to the Orphanage and looked into the work can truthfully deny that a good work has been accomplished considering the condition of most of the children when they were received. For cleanliness, system, moral and spiritual training, we believe the Orphanage stands second to none in these surroundings. That may be saying a great deal, however, all things considered, we believe that this assertion will bear inspection. The school is a model. A good work is being done, the virtue of it principally is, that children receive a spiritual as well as moral and intellectual training. The work in the Orphanage is laid out in divisions and assigned to the different members of the Orphanage in program order.

We must confess, however, that there are dark seasons, especially to those who have the work at heart, since there are crying needs from time to time for which there at times does not seem to be any provision. However, our hearts rejoice to recall the fact that there are those who came to the aid of the Orphanage in a noble mamer, and have expressed themselves that they believe it was a call of God to contribute toward the needs of the Orphanage.

We take the liberty to quote the expression of a certain old brother and sister as follows: "We had intended to donate one thousand dollars towards the Endowment Fund at our death, but in looking at the needs of the Orphanage at present, we concluded that since we had the money, we had better give it while we have it and let the managers apply it as they think proper." Had it not been for such gracious gifts, the Orphanage would have been materially lacking. We know that our work is not without criticism. There are those who think that the children are raised to idle away their time in the city. In reply to this, we will say that this is positively not the case. They are taught to work all kinds of work that is around a house, but one fact we admit, we cannot teach them farm work as we expressed ourselves a year ago and now we see the need all the more of making provisions to impart such an industrial training also.

THE FARM.

General Conference of 1907 granted the privilege to the Managing Board to purchase a farm and move the Orphanage and make such provisions that boys as well as girls can be harbored. Our hearts are made to bleed sometimes when we look at the condition of our roving boys, who are practically castaways, who need Christian homes and training more so than the girls and yet there is no provision.

The Managing Board during the past year has considered a number of places, made in-

spections of different farms, but unfortunately so far none were found yet that there were not more or less serious disadvantages for a work of this kind. The question is generally put, "Where should the money come from?" We admit that that is a serious question. On the other hand, we believe that if a farm would be bought that some of our brethren and sisters could see that the work is really undertaken that some would be impressed at least to contribute some towards the purchase without interest. We know of some who have volunteered already, and more than that, with the amount of money that it costs to sustain an Orphanage in the city, we could buy a good-sized farm altogether on debt, pay interest at at the rate of 6 per cent. and still have money left over and above what the farm would produce; and since a good farm would be a staple investment, and we have this that even a farm bought and operated in the name of the Lord will be under his blessing. We earnestly plead that our brethren and sisters will each feel a concern in this matter since souls are at stake, and through the instrumentality of the Orphanage that destinies are formed that will make useful people in the vineyard of the Lord.

Sister Anna Shank, of Marietta, Pa., was appointed as Secretary and Treasurer upon my resignation at Conference 1907, but on account of her home surroundings, she could not well take up the work, and therefore kindly asked to be excused, which was granted her, however not without regret. Brother David M. Book, of Hummelstown, Pa., has consented to take up the work to act as Secretary and Treasurer, and we believe that with proper love shown, he will prove an efficient worker in the Orphanage. We thus recommend him to Conference to be confirmed as such.

There are at present three workers outside of the teacher at the Orphanage, two of whom get a nominal pay for their labors, besides donating again considerable of their earnings for the sustaining of the work. One of the inmates who became on age is now employed; who so far proved herself an efficient worker and we have the confidence that she will continue to improve. The time, however, is at hand that something should immediately be done by way of securing another matron, since Sister Hannah Baker has presented herself in 1907 as a Foreign Missionary worker, and was accepted as such. She feels that the time is ripe that she should move out. We are glad that she was bound by the cords of love to stand by the work as long as she did, but we feel that the work at the Orphanage should not any longer stand in her way, when we consider the efficient material that we have throughout the Brotherhood, who would be fully capable

of taking her place. The principal difficulty seemingly is, that those who are impressed to help in the work feel their inability. To such, we would say, do like David did when he met Goliath. He did not consider his strength, his ability, his agility, but he said, "I come in the name of the Lord," and he was a remarkable conqueror. May the Lord impress someone to step forward and say, "Here am I." Sister Fannie Engle has been a good helper, but as we learn, she anticipates to divide up her time among her children and the Orphanage. We feel all the more impressed to call for volunteers. With these remarks, we present our report to General Conference for approval, rejection or advice.

Sec. 2. We are glad to report that God has been with us, and that the brotherhood has bravely stood by the work financially as well as with their prayers.

And while we have no special stir on the line of soulsaving, we are glad that a few made covenant with God, and hope they may be kept faithful. The Lord is calling some into active work among whom is Bro. Frank Mall who so definitely has been called to slum work, and has made application for the same.

He will depend on the Lord directly for support.

One of the most interesting characters of this place is Mother Jones, who is 96 years of age. We celebrated her last birthday anniversary by having a prayermeeting at her cottage. She was very happy and rehearsed a glorious recent experience which was so very inspiring. It was

as follows: "I was so very tired," said she, "and lay down to nap, when suddenly there shone all about me a most beautiful and effulgent heavenly light, and I rested supremely sweet, far sweeter than ever before in all my life, and I imagined I was going up, and was sure the Lord was taking me home to Heaven. O, I was so elated in that condition and had no desire whatever to remain on earth any longer, because I was so very happy and the rest so indesirably sweet. The vision finally faded away and I was so sorry that I had to remain but the Lord revealed to me plainly that this is the way I'll die-just sweetly fall asleep in Jesus." She related this with so much heart, soul and pathos that we wept for joy. She was baptized about eight years ago in the Des Moines River. Some of her friends tried to discourage her, by saying she was too old to stand immersion, but in reply she said, "I'll be baptized if I die in the water." She stood it so nicely to the surprise of her friends who witnessed her baptism.

Bro. D. W. Weigle, a resident member of this city, has charge of the jail services and is doing good work—these services are held every

Wednesday afternoon at 2 o'clock.

We hold four services a week at the Mission and two at the Gospel Temple church. Besides these services we have a Bible Class which meets every Wednesday evening. We teach by topics, giving the lesson written or printed one week in advance. The interest is good and increasing. On the same evening we teach vocal music free of charge. Thus we are kept quite busy.

Our Mission meetings no doubt would have been crowned with greater success, if we would have had a more convenient building. We had a buyer for the mission property last Fall, were offered \$4,000 cash without commission but the trustees thought we should hold the property at \$4,500—finally we were just about ready to consummate the deal at \$4,300,—when the financial flurry struck the country and the deal fell through for the present with that party. Hence we were obliged to shift along with the old building.

We are not without trials and tests and Satan has a strong hold on the people so that it is difficult to get the people to take the narrow road that leads to Heaven,—lodgery, clubs, divorces and many other of the present-day evils make it most difficult to reach souls, but we will continue to "sow by all waters" trusting the Lord for fruitage.

With cheerfulness, and a deep feeling of unworthiness we submit the above report to General Conference of 1908.

ELMER MISSION.

Report of Elmer Mission, to General Conference Brethren in Christ, 1908, Greeting:

SANDUSKY, MICH., April 7, 1908.

We have noticed in the VISITOR that missionaries are requested to make a report to Conference. Perhaps this would include us. (See General Conference Minutes 1907 Art. 28). Our financial report is as follows:

About ninety dollars of the above amount was used to pay debts contracted before we entered the work at Elmer. I did some work in barvest last year and run a steam engine for sometime, and am now working at carpenter work. We also had a garden last year. In this way we have been supported. We pay two dollars a month house rent. Sister Powell's health has been very poor during the winter and spring and for that reason house work has occupied part of my time. Elmer had been noted as being a hard place to work but during the time that Brother Myron Taylor worked here, which was about seven months, the work was greatly rewived. During that time Brother J. R. Zook conducted revival services, two persons that made a start in the meetings were baptized soon afterwards.

We moved here June 7, 1907 and took up the work. While we were used kindly, we did not receive a very hearty welcome. Being somewhat weak ourselves, it made it hard work to carry out various duties that rested upon us. Later on, we began to notice that the Lord was at work in the place. Two persons received saving grace. The last part of March, we had revival meetings in which Brother Lyons of Carland, and Brother Kitely, of Yale, (ministers) assisted us; while there was not perfect unity among us, yet four souls found peace with God. These six spoken of are likely to follow the Lord in baptism soon or at least some of them.

We organized a Sunday-school soon after we arrived here. While it was a new thing, we had a fair attendance but soon it was run on a very

small scale, but now the interest is gradually increasing. We have about twenty-four members of the Sunday-school besides some visitors. During the year, the work has had some drawbacks, partly on account of our failure and partly on account of the failures of others: nevertheless we have great reason to rejoice over the good that has been done and we believe that this is the sum, through God's great mercy in answer to prayers of the Canadian brethren and that of others. We do not know if the Church is a mission church or not.

P. S.—We have started to build a church shed. About one-half of the money is raised and more is promised.

HOME MISSION BOARD YEARLY RE-PORT-GEO. DETWILER, CHAIRMAN.

Sec. 2. The Home Mission Board makes re-

port of the following:

In accordance with decision of Conference of 1907, under Sec. 6, page 23, of Conference Minutes, the Home Mission Board stationed Brother J. D. Powell and his wife at Elmer. Mich., to take charge of the work at Elmer Mission. With a view of assisting Carland Mission by procuring farm help for Bro. Jonathan Lyons, the Board made the need known through the Visitor with an appeal for some able-bodied man to offer himself as a helper in the labors of the farm, in that way relieving Bro. Lyons so that he would be more free to attend to his pastoral and ministerial duties. To this appeal there was no response, and consequently no relief came to Bro. Lyons.

The effort to secure a resident minister for Pelham Mission proved equally abortive; however, not because no minister could be secured. Early in the Conference year a minister living isolated offered himself for the work being anxious to move among the brethren. In the meantime the Pelham brethren had their eve on another brother whom they thought they could secure for the work. This being the case the chance that promised success was let slip by, and Pelham has been supplied from Wainfleet and Bertie during the year.

The only work undertaken by the direction of the Home Mission Board was the sending of Brethren T. A. Long and John R. Herr on a mission trip to visit isolated members in eastern Kansas, and in Missouri: also sending Bro. J. H. Byer, of Lake Ann., Mich., to Wabash, Ind., there being a call to hold some meetings there. He reported having had good meetings, there being a number of conversions. The people among whom he labored are poor, quite a proportion are of the colored race. There was much inquiry as to the Brethren's faith and practice.

The above report was approved.

HOME MISSION BOARD-CONFERENCE REPORT.

PHILADELPHIA MISSION.

Sec. 3. WHEREAS. The work of the Philadelphia Mission District is becoming so extended, Resolved. That this Board recommends to Conference to consider the advisability of appointing a suitable brother or brethren, who are not residents of Philadelphia Mission District, as assistants to Brother Stover in the management of the Mission affairs.

Sec. 5. Whereas, It is of great importance that the Des Moines work shall be properly

cared for; therefore,

(a) Resolved, That Bishop J. R. and Sister Anna Zook continue to have charge of the work, and that they be at liberty to secure, if they can, suitable assistants as the work may require; and,

(b) Resolved, That this Board recommends Conference to consider the advisability of disposing of the Mission property in Des Moines, Iowa, and with the proceeds and funds in hand improve the vacant lot on the Gospel Temple property, thus providing a residence for the workers, concentrate the work, reduce expenses, and from this central location do Mission work in different sections of the city by such ways and methods as may commend themselves as feasible.

Sec. 6. Whereas, Brother J. H. Byer, of Lake Ann., Mich., spent sometime in the city of

Wabash, Ind., during last year; and,

WHEREAS, The meetings held were well attended and a commendable interest manifested pointing to the need of some further effort; therefore,

Resolved, That this Board recommends Conference to encourage the work to the extent that Brother Byer spend sometime during the coming Summer on a more or less extended effort.

and that Bishop J. A. Stump, of Nappanee, Ind., be associated with Brother Byer in the effort.

ELMER MISSION.

Sec. 7. Whereas, Brother J. D. Powell was given charge of Elmer Mission by Conference of 1907; and,

WHEREAS, His management of the work in his charge has failed to give the satisfaction which

Resolved, That Conference relieve him of his

charge.

Sec. 8. Whereas, It is of great importance that competent workers be found who will be able under the blessings of God to labor in and successfully care for such Mission fields as Elmer and others: and.

WHEREAS, The Church in her methods of work has heretofore provided no satisfactory way by which such needed workers can be secured in that there has been no legislation passed which enables her to transfer workers to such needy fields: therefore.

Resolved, That this Board recommends Conference to devise some plan whereby the Church will be in a position to supply this need;

and,

Sec. 9. Whereas, The work of the Church in the State of Michigan is subject to great and peculiar difficulty, owing largely to the large territory over which the small number of members is scattered; and,

WHEREAS, There is no resident Bishop in any one of the parts of the field in the State; there-

fore.

(a) Resolved, That this Board prays Conference to take steps to accomplish the appointment of a Mission Bishop for the State who shall have the care and oversight of the work of the Church in the State, and whose circumstances

are such as will enable him to give his tim- to the work as may be needed to properly en courage the work and shepherd the flock; and,
(b) Resolved, That Conference consider the advisability of strengthening the ministry at the

Secretary's Report, F. M. Board, for the $Y_{\rm EAR}$

Sec. 7. Certain questions of important and grave character having arisen in the field, during the year, the following resolutions have been adopted and incorporated in the Minutes of the Foreign Missionary Board.

(a) In reply to an inquiry from H. P. Steigerwald, the Board responds as follows: "It is the conviction, sense and decision of the F. M. Board, that the Macha Mission, N. W. Rhodesia, South Africa, sustains the same relation to you as Bishop as do all the other out-

post Missions."

(b) "It is also further resolved, that no new Mission stations shall be created hereafter without a written consent of the F. M. Board, with the majority of the officials in the Foreign Mission field. The manner in which new outposts shall be established shall be determined by the same factors. This ruling shall not, and does not reflect on previous methods, or operations but simply stands as a precedent for future methods of operations, believing that systemization is an essential element to the progress of Missions as well as any other business or operations."

(c) "These rulings and decisions shall be considered authentic until General Conference or the F. M. Board shall advise otherwise."

Duplicate copies of above rulings were mailed to the respective stations, to which they par-

ticularly applied.

In reply to an inquiry from Macha Mission, subsequently received, the following was ren-

dered:

"You have inquired relative to the extent of Brother Steigerwald's jurisdiction as a Bishop over outpost stations. The duties of a Bishop are defined in General Conference Index, page 252, Art. 2, which belong to him by virtue of his office. The Bishop, however, has power to authorize temporarily, any ordained minister to perform his (the Bishop's) functional duties, if he deems it proper. In your case, since your Mission is so remote from the Bishop, it would seem proper to us if Brother Steigerwald would empower Brother Taylor to perform at least some of the functional duties that belong to the office of a Bishop. All outpost Mission stations in South Africa are amenable directly to the F. M. Board for all expenses, and are also supported by the Foreign Mission Fund. An annual financial report is expected from each of all the stations to the F. M. Board in time to report to General Conference on third Wednesday of May each year. Instructions relative to the creation of new Mission stations in South Africa were incorported in a previous letter.

OUTPOST MISSION STATION DEFINED.

We look upon the Matoppo Mission Station as the original and central Station, as well as the home of the Bishop, and all other Stations subsequently created in South Africa as outposts. This is the sense in which we have used the term thus far. Believing that we have covered all your questions of inquiry and hoping we also clearly understand each other in this great work of propogating the gospel at Macha, Rhodesia, S. Africa, we conclude by wishing you all the blessing of God in your self-sacrificing labors of love. You have our sincere prayers and cooperation. We also appreciate the good influence you have exerted in Cape Town, S. A., which has won the confidence of noble Christian characters and created a desire in them to unite with you more fully in the work of the Master.

Conference Report of Foreign Missionary Board.

Sec. 8. To General Conference 1908, Greeting: The Foreign Missionary reports have all been read and carefully examined and approved, and are hereby submitted for confirmation by General Conference.

(a) Whereas, Brother H. P. Steigerwald of South Africa, feels the propriety of an authoritative expression on his official title as Bishop, in order to authenticate his proper relationship to the various Mission Stations over which he is recognized as Bishop by General Conference and by official correspondence by the Foreign Missionary Board; therefore be it

Resolved, That this Conference authorizes the title of Bishop in South Africa to Brother H. P.

Steigerwald.

(b) Whereas, The Council of the Missions in S. Africa has decided that Mtshabezi Mission is in great need of a team of eight donkeys and harness for individual use, having previously depended, and even now depend, upon the teams of the other Missions; and,

(c) WHEREAS, The Missions are quite remote from each other, this method of co-operation has proved impracticable; be it therefore

Resolved, That we appropriate the sum of four hundred and twenty-five dollars from the F. M. Fund, which is given as the approximate

cost of said team and harness, for this purpose.

(d) Whereas, It has been our experience in relation to our Foreign Missionary workers that those who are subject to certain physical ail-

ments before taking the field usually become debilitated when they enter foreign climates; and,

WHEREAS, Our Foreign Mission workers have

expressed a similar conviction;

(e) Whereas, Other Missonary Societies have been forced to the same convicton; therefore,

Resolved, That all applicants for the foreign fields undergo a physical examination by a competent professional; and be it further

Resolved, That if the pronouncement of said examination be sufficiently strong, they shall be

considered physically qualified.

(f) Whereas, Repeated requests have come to us from the F. M. W. that a competent member be sent to the foreign field in order that the Church, and especially the F. M. Board, may have a more perfect knowledge of the condition of the needs of the F. M. work, etc.; therefore be it

Resolved, That this Conference recognize and

encourage such project.

(g) Whereas, The F. M. Board is in receipt of a letter of inquiry from Elbert T. Hemming, of Cape Town, S. A., asking for information in relation to the necessary steps and qualifications for church membership; and,

WHEREAS, we have duplicate copy of reply to

the aforesaid letter; and,

WHEREAS, we also have a copy of a letter for instructions to Elder H. P. Steigerwald, in reference to the same matter; and,

(h) Whereas, the aforesaid letters cover a new field of experience in the F. M. work of the church: therefore be it

Resolved, That the above named letter be spread upon the Minutes of this Conference as a precedent for similar cases in the future.

(i) WHEREAS, The F. M. Board has again reconsidered the propriety of an advanced step in the establishment of the Rescue Home and Girls'

School of South Africa; and,

(j) WHEREAS, no new developments have been discovered to justify the F. M. Board to suggest any action to General Conference than it already has suggested; therefore be it

Resolved, That we refer to resolutions concerning the same on page 47, Minutes of General Conference of 1907, as our present concensus;

and.

Resolved, That the F. M. Board write an official letter to the workers of S. Africa, making special inquiry as to the propriety and possibility of an early advanced step in the establishment of the aforesaid school.

(k) WHEREAS, a request comes from India for the improvement of the forty-acre tract of land

leased for Mission purposes; and,

(1) WHEREAS, The F. M. Board lacks sufficient knowledge to make an intelligent suggestion to General Conference or take any definite action in the matter; be it therefore

Resolved, That the Secretary of the F. M. Board open private correspondence with the workers at Lucknow, India, to ascertain further information in reference to the proposed project.

Resolved, That the Foreign Mission reports, preambles, resolutions and the Secretary's general report, as hereby submitted, be reproduced

on the Minutes of this Conference. Signed,

MATOPO MISSION GENERAL AND FINANCIAL REPORT.

Sec. 9.

In view of the vast and extensive fields that remain as yet unentered by missionary effort, and also of the pressing need of many more Godsent Foreign Missionary workers, to arduously press into those fields with the message of life and peace; the Holy Spirit having laid upon the hearts of dear brethren and sisters, the desire to carry the glad tidings of God's saving grace to such of the heathen whom they in their own humble sphere, may be permitted and enabled to reach; the appointments of the Foreign Missionary Board, confirmed by General Conference (under Art. 48, page 57, Conference Minutes 1907) have been made.

The way opening under the Lord's blessing and kind assistance of those interested in the Master's cause, the following appointees have moved out. Brother Myron Taylor, of Elmer, Mich., set sail from Boston, U. S. A., for South Africa, toward the close of May, 1907. After safely arriving at Cape Town, S. A., he felt impressed that it was the Lord's will that he remain there for awhile to assist a noble Christian friend, whom he had met through a difficulty. He continued there for sometime before moving Northward. Before proceeding to Kalomo, N. W. Rhodesia, remained a little while at Matopo Mission, as advised by the Foreign Missionary Board, finally arriving at the Macha Mission Station on November 6, 1907, this Station being his appointment from the Board.

Sister Lizzie Engle, Abilene, Kansas, sailed from New York, on June —, 1907, on steamship "City of New York," American line, enroute for Cape Town, South Africa, arriving at the Mtshabezi Mission Station sometime during the Summer or early Fall of the year.

Brother Jesse Wenger and Sister Docia Wenger, Englewood, Ohio, and Mary Heisey, Clayton, Ohio, who have received appointment by the Foreign Missionary Board to the Macha Mission Station, N. W. Rhodesia, South Africa, sailed on American line steamship "St. Louis," from pier No. 15, New York City, N. Y., on March 28, 1908. Owing to their recent departure, no intelligence of their arrival in Africa could yet reach us.

The situation and status of the work in the field, as gleaned from the letters to the Board, and annual report to General Conference, will be summarized as follows:

MATOPO MISSION STATION.—H. P. STEIGERWALD, OVERSEER.

Sec. 10.

The recent improvements made at the Matopo Mission consist of two buildings which have been erected during the year. The one, a school-

house, about five miles west of the Matopo Mission Station, used for school and religious worship. Formerly, the school had been held in a hut at a kraal, later it became obvious that the erection of a house for school and worship was advisable at a location more central among the natives, therefore the erection of the building.

In the annual report, Brother Steigerwald says, "Here is where Brother Nyamazana is teaching, and as far as we can see, is doing splendid work. There were nearly one hundred and fifty people present at the opening of this house, and to our surprise many old men, including the chief. They expressed a desire of having their children

taught in the right way."

The other building is a cow-shed. The erection of said buildings added about one hundred and twenty-five dollars to the regular expenses at this Station. The £200 Stock Fund, forwarded during the year, has been invested in 15 cows and five donkeys, the increase to the herd, reported March 13, 1908, is thirteen (13) calves and two young donkeys. One two-furrow disc plow has been purchased to expedite farming operations.

The regular financial report will appear in its proper place in the Minutes of General Confer-

ence 1908 in detail.

In his report of the spiritual work, Brother Steigerwald says, "there were no additions to the church, but a fair sized "inquirers' class" has been kept up. We feel there is not the eagerness to hear about God that we desire to see, at least some, who, we feel, are seeking for the truth." The inquirers' class is considered by some workers an important feature in the African Mission work. It consists of such who have expressed a desire to follow the Lord, and to be instructed more fully as to what it means to follow the Lord and become a member of his

body. When their walk has proven that they wish to obey God, and that they understand and discern more fully the Lord's body, they are baptized and admitted into the church. At the close of the year 1907, there were 38 who were considered worthy to be retained in the class.

ORDER OF SERVICE.

The regular exercises for Sunday consist first of the instruction to the inquirers' class, followed by the Sunday-school, usually continuing from 10.30 a. m. to 3 p. m. In the evening a Bible class is held in the native language, in which the Bible is studied by chapter, questions asked and answered. All who are able to read participate in this study. Thursday, 7 a. m., gospel meeting usually followed by testimony. Daily reading and prayer in both languages.

Monthly members' meetings are held, where special instructions on the Christian life are given. Bi-weekly meetings at the new schoolhouse. Kraal visiting when not crowded out by the pressure of secular duties. In September, the Sunday-school was re-organized. Enrollment, 152. Average attendance for four months, 55. Eight classes, all taught by native Christians.

MAPANE MISSION STATION, SOUTH AFRICA—LEVI T. DONER, OVERSEER.

Reports the year one of blessing, in the enjoyment of reasonably good health, joy in the soul, and the pleasure of leading some souls to Christ, along with the other work they were permitted to do. The Sunday-school has added to its staff of teachers several native brethren and sisters, the school being divided into seven classes.

On November 2 and 3, 1907, a love feast was held at this Station and a baptismal service observed, in which three native brethren and three sisters were received into church fellowship and baptized. "Probably the boldest aspect of the development of the Christian natives is the steadfastness of those who were baptized last year. We are glad to report, that with the exception of one sister, as far as we can ascertain, all have stood true to their convictions.

It would be an injustice to this report not to mention what the Lord has done for our dear sister Setjokupe. It is a marvel that a raw heathen could be changed to a zealous worker for the Lord and prove a worthy example of what she professes in so short a time. Her unreserved consecration to God has made deep im-

pression on her associates." A number have turned into the inquirers' class. To enter this class means to them to believe on Jesus and accept him as their Savior, and to forsake all evil

when they learn what sin is."

The operation begun in the construction of a dwelling house, house of worship and school-room, referred to in the Secretary's report of 1907 (Art. 40, page 40, General Conference Minutes 1907), have been completed (at a total cost of \$473.95) to the convenience and appreciation of the workers. The Lord has blessed this Station in a special way, through the liberality of a brother in Pennsylvania, U. S. A., and a "United Christian" brother in connection with other offerings, which has enabled the workers to procure a good supply of cows.

The dairy industry being the strongest source by which the Mission work in Rhodesia can hope to be made more self-supporting. Improvements for the safe-keeping and care of the cows were added to this Station out of the above special offerings. Sec. 13. MTSHABEZI MISSION STATION, SOUTH AFRICA-HARVEY I. FREY, OVER-SEER.

Another year has rolled around for this Station and carried with it its record forever. Brother Frey reports, "With us the year has brought toil and rain, sorrow and hard problems; it has also brought joys, sunshine and victories;" but the consciousness of the Divine Presence with them, causes the workers to gratefully exclaim, "Praise the Lord." Sister Maria Werkman came to the assistance of Brother and Sister Frey in May of the past year, but was with them only a few weeks when her body began to show signs of weakness. Her physical condition still growing worse, and finally became so serious that the workers at the three above named stations, together concluded that she should return home to America without delay. Thus being compelled to leave the field after a brief period of service in the Foreign Mission cause, she arrived safely in the homeland in the early part of the year 1908, where, under God's blessing, she has been permitted in some degree again to regain her health.

Sister Lizzie Engle came to the assistance in the work at this place shortly before Sister Werkman's departure, enjoying the work, she proves herself a blessing in it. We report considerable improvement at this station. The workers, together with the boys staying with them, have made and burned eighteen thousand brick, and built the house for worship and school purposes. Besides this, another workers' hut, another boys' hut, hen-house, store-room, etc., have been constructed.

In the spiritual part of the work, we report an average Sunday attendance of about seventyfive for the year (last year an attendance of less than sixty), showing an encouraging increase in interest in the services.

On November 4, 1907, at 11 a. m. the brethren and sisters (white) of Matopo, Mapane and Mtshabezi Mission Stations met together in conference at this Station, in order to enable them more unitedly and successfully to press forward the work in their respective fields. The meeting was presided over by H. P. Steigerwald, Harvey Frey, Secretary. A copy of the Minutes of this Conference was forwarded to the Secretary of the F. M. Board, and shall receive due consideration at the ensuing session of the Board.

In January, 1908, the new church building was dedicated for the worship of God, when a love feast was also held, and baptismal service observed. Seven were baptized on this occasion. In the day-school, fifty-four pupils were enrolled for the year, and was open for all who desired to learn with Sister Frey as teacher. Besides regular services at the Mission, some beginning work from six to ten miles north, south and east of the Station has been done. Said places appear to be promising fields for future operations.

MACHA MISSION STATION, KALOMA, N. W. RHODESIA, SOUTH AFRICA, IN CHARGE OF SISTERS H. FRANCIS DAVIDSON AND ADA G. ENGLE.

The annual letter to General Conference of 1908 is full of interest, from which we report the following:

The material improvements at this Station during the year consist of the construction of three new huts; to wit, a school-house, a hut for new missionaries and one for the boys as seen in the financial report.

The outlook for school was not very promising at the opening of the past year. Only three came to the school from their homes during the year and they only a short time. About the middle of February, the Chief brought his little son, saying he desired his boy to remain at the Mission to learn, and to work for his expenses. A week later another boy came; thus one after another followed until at the Christmas vacation seventeen boys, ranging in age from eight to eighteen years, were staying at the Mission and going to school.

The report of the girls is not so favorable, they cannot be prevailed upon to come to school or church services. The only larger ones who have been to church were five who walked eight miles on two successive Sabbaths. The attendance of men and women at the church services varied from thirty to ninety of the most regular in attendance; twelve came to the altar for prayer. After the completion of the schoolhouse, two services were held each Sabbath, Before the year closed an inquirers' class of about twenty-five was formed. Owing to the threatened native disturbance, the Mission passed through a critical time, during the year and the timely arrival of Brother Hemming from Cape Town coming to the aid of the workers in the latter part of August, 1907, was looked upon as providential and proved a great relief to them in their critical situation. Brother Myron Taylor arrived in the early part of November as a co-worker at this place.
